### PRIZE DRAW TERMS AND CONDITIONS FOR PRIZE DRAW: MATCHDAY HOSPITALITY DRAW

#### Information about other people

If you provide information to us about any other people, you must give them a copy of the Club Privacy <https://www.wba.co.uk/privacy-policy> Policy so that they understand how their information will be used. You should only provide information about them if you are authorised to do so.

1. By entering into this prize draw you are confirming that you have read, accepted and agree to be bound by these Terms.
2. The prize draw is free to enter and no purchase is necessary; however, each entrant will need an internet connection and no refund may be claimed for expenses incurred in participating in the competition, including in relation to use of the internet.
3. The prize draw is open to Promoter home supporters aged 18 or over residing in England, Wales or Scotland who are participating in hospitality in the Richardson, Millichip, Executive Boxes, Bassett and Pennington suite at the QPR match held at The Hawthorns on Tuesday 24<sup>th</sup> October 2023 (the “**Match**”).
4. Employees or consultants of the Promoter or the Promoter’s group companies, their families, agents or any third party directly associated with administration of the prize draw are not permitted to enter the prize draw.
5. The prize draw shall be open for entries between 17:00 on 24/10/2023 (“Opening Time”) and 20:00 on 24/10/2023 (“Closing Time”). Entries received after the Closing Time will not be considered.

7. Only one entry per person is permitted. Entries on behalf of another person will not be accepted and joint submissions are not allowed. The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize draw.
8. Entries submitted that are (a) automatically generated by a computer, (b) completed by third parties or in bulk, (c) illegible, have been altered, reconstructed, forged or tampered with, (d) incomplete

- (e) submitted by an individual not eligible to participate in the prize draw and/or (e) fraudulent are not valid entries and will not be submitted into or removed from the prize draw.

19. The Promoter reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
