PRIZE DRAW TERMS AND CONDITIONS FOR PRIZE DRAW: Win a WBA Hawthorns stadium tour voucher

Information about other people

If you provide information to us about any other people, you must give them a copy of the Club <u>Privacy Policy</u> so that they understand how their information will be used. You should only provide information about them if you are authorised to do so.

- 1. By entering into this prize draw you are confirming that you have read, accepted and agree to be bound by these Terms.
- 2. The prize draw is free to enter and no purchase is necessary; however, each entrant will need an internet connection and no refund may be claimed for expenses incurred in participating in the competition, including in relation to use of the internet.
- The prize draw is open to Promoter home supporters aged 18 or over residing in England, Wales or Scotland.

- 7. Only one entry per person is permitted. Entries on behalf of another person will not be accepted and joint submissions are not allowed. The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize draw.
- 8. Entries submitted that are (a) automatically generated by a computer, (b) completed by third parties or in bulk, (c) illegible, have been altered, reconstructed, forged or

tampered with, (d) incomplete (e) submitted by an individual not eligible to participate in the prize draw and/or (e) fraudulent are not valid entries and will not be submitted into or removed from the prize draw.

The Promoter will make all reasonable efforts to contact the prize winner by notifying the prize winner via private message using the Instagram account that the prize winner used to enter the prize draw. When the prize winner is notified by the Club that they are a prize winner, the prize winner will be required to provide their name, email and a postal address to claim their prize. If a winner cannot be contacted or is not available, or has not claimed their prize within 5 days of being notified by the Promoter, then the winner's prize will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described above. Subject to events outside the reasonable control of the Club, the prize will be sent to the winner by post within 5 days of the Club being notified of the relevant postal address (except where the prize has been forfeited in accordance with clause 13 above or has been provided to the prize winner in person.
- 15. The prize for the winner is non-exchangeable, non-negotiable, non-transferable and no cash alternative is offered. The prize winner shall be solely responsible for all taxes and the reporting consequences thereof and for any other fees and costs associated with the prize. If any taxes, costs and/or fees are levied against the Club in respect of

the prize, the Club may recover those taxes, costs and/or fees from the prize winner and the prize winner agrees to reimburse the Club for such taxes, costs and/or fees. The prize winner shall also be responsible for all costs relating to the use of the prize.

- 19. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Promoter reserves the right to refuse entry or refuse to award the prize to anyone in breach of these terms and conditions.
- 20. The Promoter reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
- 21. Insofar as is permitted by law, the Promoter will not in any circumstances be responsible or liable to compensate the winner or any other person/third party or accept any liability for any loss, damage, personal injury or death occurring as a result of entering the prize draw, winning the prize draw and/or taking up the prize except where such liability is caused by the negligence of the Promoter or that of their employees. Your statutory rights are not affected.

Gift Vouchers will be sent electronically to the email address provided by the purchaser. No physical gift vouchers will be provided. If at the time of redemption, the cost of your purchase (i) is less than the balance on the Gift Voucher, the unused balance will remain on the Gift Voucher for use towards future purchases of a stadium tour or (ii) exceeds the balance on the Gift Voucher, the remaining amount must be paid by you using one of the accepted payment methods acceptable to the Club.

Limitations of Gift Voucher:

- Gift Voucher can only be redeemed against purchases of a stadium tour of The Hawthorns. They cannot be redeemed against any other purchases.
