

## **Terms and Conditions – Baggies Bonanza Matchday Lottery**

### **1. Promoter and Registration**

The Baggies Bonanza Matchday Lottery ("the **Lottery**") is promoted by The Albion Foundation, a charitable company registered in England and Wales (Company Number: 04012682) and a registered charity (Charity Number: 1081948), with its registered office at Ray Hall Lane, Birmingham, B43 6JF ("the **Promoter**").

The Promoter is registered with Sandwell Metropolitan Borough Council under the Gambling Act 2005 to operate small society lotteries (Registration Number: [25/000149/LOTT]).

### **2. Acceptance of Terms**

2.1 By entering the Lottery, entrants confirm that they have read, understood, and agree to be bound by these Terms and Conditions.

2.2 The Promoter reserves the right to refuse entry, disqualify participants, or withhold the Prize from anyone in breach of these Terms and Conditions.

### **3. Eligibility**

3.1 Entry is open only to individuals aged 16 years or over, residing in England, Wales, or Scotland.

3.2 Entries from anyone under the age of 16 are prohibited. Proof of age may be required.

3.3 Employees, officers, or consultants of the Promoter or West Bromwich Albion Football Club, their immediate families, agents, or any third party directly involved in the administration of the Lottery are not eligible to enter.

3.4 By entering the Lottery, entrants warrant that they are eligible and legally entitled to do so. The Promoter may require proof of eligibility before awarding the Prize.

### **4. Ticket Sales**

4.1 Lotteries are normally held at each home league fixture of West Bromwich Albion Football Club which is played at The Hawthorns Stadium.

4.2 Tickets cost £2 and are available:

- (a) Online at <https://register.enthouse.com/ps/event/BaggiesBonanza> and (b) In-person via authorised matchday sellers at The Hawthorns on matchday.

4.3 Tickets must be paid for in full before the draw. Tickets are non-refundable.

## **5. Entry Deadline**

5.1 All tickets must be purchased before the kick off of the relevant match ("**Closing Time**").

5.2 Tickets purchased after the Closing Time will not be entered into the Draw and will be deemed void.

## **6. The Draw**

The draw will take place during the half-time interval of the relevant home fixture. The winning ticket will be selected at random ("the **Draw**").

## **7. Prize Structure and Use of Proceeds**

7.1 The winner will receive 50% of the total ticket revenue received for that match, subject to a maximum amount of £1,000 (One Thousand Pounds) ("the **Prize**").

7.2 The remaining proceeds (after deduction of any permitted costs) will be retained by the Promoter and used exclusively to support its charitable objectives.

7.3 The Prize is non-exchangeable, non-transferable, and cannot be substituted.

7.4 The winner is solely responsible for any tax or reporting obligations arising from receipt of the Prize. If any taxes or charges become payable by the Promoter in relation to the Prize, the winner agrees to reimburse the Promoter on request.

## **8. Winner Announcement**

8.1 The winning ticket number will be announced via the stadium public address system and displayed on the Promoter's official website and social media channels.

8.2 Subject to the winner's consent, their surname and winning ticket number will be made available to anyone who contacts [fundraising@albionfoundation.co.uk](mailto:fundraising@albionfoundation.co.uk).

8.3 If the winner objects to their personal information being published or disclosed, they should notify the Promoter when claiming the Prize. The Promoter will still provide the necessary information to the Advertising Standards Authority if required.

## **9. Claiming the Prize**

9.1 The winner must claim the Prize within 28 days of the draw by:

(b) Calling 07946 482727 (Monday to Friday, 08:30–16:30).

9.2 The winner must provide their full name, proof of ID, winning ticket, and address (including county of residence).

9.3 Prizes may not be claimed by third parties.

- 9.4 Failure to claim the Prize within 28 days will result in forfeiture, and the Prize will be deemed a donation to The Albion Foundation.

## **10. Disqualification**

The Promoter reserves the right to disqualify entries or withhold the Prize in cases of actual or suspected fraud, misconduct, breach of these Terms and Conditions, or other reasonable grounds.

## **11. Invalid Tickets**

Tickets will be deemed invalid if they are:

- (a) Defaced, altered, duplicated, illegible, forged, incomplete, or tampered with;
- (b) Submitted by an ineligible entrant; or
- (c) Obtained in breach of any applicable law or these Terms.

## **12. Cancellation or Amendment**

The Promoter reserves the right to cancel, suspend, or amend the Lottery (in whole or part), including these Terms, where necessary due to circumstances beyond its control. Notice will be given via the Promoter's website and/or stadium announcements.

## **13. Governing Decisions**

The Promoter's decision on all matters relating to the Lottery is final. No correspondence or discussion will be entered into.

## **14. Liability**

14.1 The Promoter accepts no responsibility for loss, damage, injury, or death resulting from participation in the Lottery or acceptance of any Prize, except where caused by its negligence.

14.2 Nothing in these Terms shall exclude liability for death or personal injury caused by negligence, fraud, or any other liability which cannot be excluded under English law.

## **15. Data Protection**

15.1 Personal data provided during entry will only be used for the purpose of administering the Lottery and as outlined in the Promoter's Privacy Notice.

15.2 By entering the Lottery, participants agree to the Promoter processing their personal data in accordance with UK data protection laws.

## **16. Jurisdiction**

The Lottery and these Terms are governed by the laws of England and Wales, and entrants submit to the exclusive jurisdiction of the English courts.

## **17. Variation of Terms**
