#### TERMS AND CONDITIONS FOR BOILERMAN'S BONUS BALL AT WBA V QPR 29.12.2025

#### Information about other people

If you provide information to us about any other people, you must give them a copy of the *Club Privacy Policy* so that they understand how their information will be used. You should only provide information about them if you are authorised to do so.

1. By entering into this prize draw you are confirming that you have read, accepted and agree to be bound by these Terms.
2. The prize draw is free to enter, and no purchase is necessary; however, each entrant will need a season ticket that allows the entrant access to the Match and an internet connection, and no refund may be claimed for expenses incurred in participating in the competition, including in relation to use of the internet.
3. The prize draw is only open to Promoter home 2025/26 full or part season ticket holders' supporters aged 18 or over residing in England, Wales or Scotland who are attending the Match that are not suffering from any medical condition that would prevent them from participating in the prize.
4. Employees or consultants of the Promoter, their families, agents or any third party directly associated with the administration of the prize draw are not permitted to enter the prize draw.
5. The prize draw shall be open for entries between 10:00 on 10.12.2025 ("**Opening Time**") and 15:00 on 18.12.2025 ("**Closing Time**"). Entries received after the Closing Time will not be considered.

7. Only one entry per person is permitted. Entries on behalf of another person will not be accepted, and joint submissions are not allowed. The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize draw.
8. Entries submitted that are (a) automatically generated by a computer, (b) completed by third parties or in bulk, (c) illegible, have been altered, reconstructed, forged or tampered with, (d) incomplete, (e) submitted by an individual not eligible to participate in the prize draw, and/or (e) fraudulent are not valid entries and will not be submitted into or removed from the prize draw.
9. In entering the prize draw, you confirm that you are eligible to do so and eligible to claim the Chance to Score. The Promoter may require you to provide proof that you are eligible to enter the prize draw and to claim the Chance to Score.

hardware or software failure, satellite, network, systems or server failure of any kind. The Promoter will not accept proof of transmission as proof of receipt of entry to the prize draw. The Promoter accepts no responsibility for any entries not validly completed for any reason.

11. A winner of the prize draw will be chosen by random draw within 24 hours of the Closing Time. The winner of the prize draw will receive the opportunity of participating in a Chance to Score on the Hawthorns pitch during half time to win a range of prizes. The Promoter will make all reasonable efforts to contact the prize draw winner by notifying the prize draw winner via email or phone (where relevant contact details are provided) within 24 hours of the Closing Time. A prize draw winner must provide their name and a postal address to claim the Chance to Score, such postal address must be a residential address in England, Scotland or Wales. If a prize draw winner cannot be contacted or is not available, or has not claimed the Chance to Score or has not confirmed they will attend the Match and want to participate in the Chance to Score within 24 hours of being notified by the Promoter, then the winner's opportunity to participate in the Chance to Score will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described above. The Chance to Score may not be claimed by a third party on a prize draw winner's behalf. You warrant that all information submitted by you to the Club is true, accurate and complete. To participate in the Chance to Score a prize draw winner must attend the Match and be available to participate at such time(s) notified by the Promoter to the prize draw winner. No match tickets to the Match will be provided to the prize draw winner or any other person. No guests of the prize draw winner may accompany the prize draw winner on the pitch.
12. **Chance to Score** means: three chances (each from a different distance as notified to the prize draw winner by the Promoter) to score a goal at half time of the Match (or such other time before or after the Match as notified to the prize draw winner by the Promoter) against Boilerman or an alternative goalkeeper as advised by the Promoter from time to time. No practice attempts are allowed unless permitted by the Promoter on the day of the Match (although the practice attempt does not count towards the three chances and therefore no prizes can be won as a result of scoring a goal on a practice attempt). For a goal to be deemed scored the whole of the ball must pass between the goalposts and under the crossbar of the goal being used as part of the competition at the Match. The Promoter will determine whether a goal has been scored, and its decision shall be final. The ball used will be the ball provided by the Promoter. The Chance to Score will be conducted in three stages and the prizes will be awarded accumulatively.
13. If the prize draw winner is successful in scoring such a goal (the "**Goal Scorer**"), then the Goal Scorer will win the prizes outline below (at the discretion of the Promoter). The Goal Scorer will have the opportunity to win one or multiple prizes. For example, if the goal scorer successfully completes chances one and three, they will be eligible to claim the prizes stated for stage one and three attempts but not the prize stated for stage two. The prize draw winner will receive a participation prize consisting of one (1) x signed copy of a WBA v QPR teamsheet. The included signatures are determined at The Promoter's discretion and the prize draw winner may not request a specific player's autograph.

- Goal scored in stage two – one (1) 2026 official calendar signed by members of The Men's First Team. The included signatures are at The Promoter's discretion and the Goal Scorer may not request a specific player's autograph.
- Goal scored in stage three – one (1) 25/26 short sleeve shirt signed a member of The Men's First Team. The included signatures enclosed are at The Promoter's discretion and the Goal Scorer may not request a specific player's autograph or shirt.
- No prizes will be provided if the prize winner fails to score such a goal. The prizes are subject to availability and the Promoter terms and conditions. The Goal Scorer will be contacted within five working days of the QPR on 29.12.2025 by the Promoter to organise the collection or postage of the prizes.

14. When participating in the Chance to Score, the prize draw winner must (i) act responsibly and sensibly at all times; (ii) not participate if they are under the influence of alcohol or drugs, (iii) not participate if they are unwell and/or are displaying symptoms of any infectious disease (including Covid-19), (iv) use any equipment provided to the prize winner safely and as described, (v) follow any safety warnings or instructions displayed or given to them in respect of the prize, (vi) comply with Club rules at all times and (vii) supply their own footwear that is deemed appropriate by the Promotor (studded or astro turf football boots) and wear their footwear throughout the participation of the Chance to Score.
