These terms and conditions, together with the documents referred to within them, set out the terms on which you may apply for Tickets under the Offer.

#### **Definitions**

In these terms and conditions (unless the context otherwise requires):

**"Club"** means West Bromwich Albion Football Club of The Hawthorns, West Bromwich, West Midlands, B71 4LF.

**"Football Authority"** means each of the Premier League, the English Football League, The Football Association, The Football Association of Wales, FIFA, UEFA and any other relevant governing body and/or regulator of association football.

**"Ground Regulations"** means the conditions of entry to the Stadium.

**"Match"** means the Adobe Women's FA Cup fourth round fixture between West Bromwich Albion Football Club and Everton Football Club on Thursday, 15 January 2026, kick-off 7.30pm.

**"Stadium"** means The Alexander Stadium, Walsall Road, Perry Barr, Birmingham, B42 2LR.

**"Ticket"** means a ticket issued for the Match as part of the Offer.

**"Terms & Conditions of Entry"** means the applicable Ground Regulations, the Club's Home Match Ticket Conditions of Issue 2025/2026 at <https://www.wba.co.uk/tickets/ticketing-terms->

### **1. The Offer**

- 1.1 The Club is offering eligible schools and grassroots football clubs the opportunity to apply for free Tickets for groups of ten (10) or more to attend the Match (the “**Offer**”).
- 1.2 Tickets are subject to availability and allocation is at the Club’s sole discretion. Submission of an application does not guarantee that Tickets will be allocated.

### **2. Eligibility**

- 2.1 Applications may only be submitted by a nominated representative of:
  - (a) a school; or
  - (b) a grassroots football club.
- 2.2 Applications from individuals, commercial organisations, agents, or professional football clubs will not be accepted.

### **3. Application Process**

- 3.1 Applications must be submitted via the official webform on the Club’s Website by the stated deadline.
- 3.2 Only one application per organisation may be submitted unless otherwise agreed in writing by the Club.
- 3.3 By applying for the Offer, you warrant that you are at least 18 years of age and legally capable of entering into binding contracts.
- 3.4 Incomplete, inaccurate or late applications may be rejected without notice.

### **4. Ticket Allocation**

- 4.1 The minimum group size eligible for the Offer is ten (10) attendees.
- 4.2 The Club reserves the right to:
  - (a) limit the number of Tickets allocated to any one organisation;
  - (b) determine seating locations; and
  - (c) allocate fewer Tickets than requested.
- 4.3 Tickets are valid only for the Match specified and have no cash value.

### **5. Supervision and Safeguarding**

- 5.1 The Club accepts no responsibility for the supervision of children or young people under the age of 18 attending the Match as part of a group.
- 5.2 The applying organisation is solely responsible for:

- (a) the supervision, conduct and behaviour of its group;
- (b) appropriate safeguarding arrangements; and
- (c) obtaining any necessary parental or guardian consent.

5.3 All children or young people under 18 must be accompanied at all times by an appropriate number of responsible adults aged 18 or over. Adult-to-child ratios must comply with the applying organisation's own safeguarding policies or applicable guidance and must be adhered to at all times.

### 6. Use of Tickets

- 6.1 Tickets must not be sold, transferred for commercial gain, or used for advertising, promotional or marketing purposes without the Club's prior written consent.
- 6.2 The Club reserves the right to cancel Tickets where they are misused or obtained using false or misleading information.
- 6.3 Applications must only be submitted for the number of Tickets that are reasonably expected to be used.
- 6.4 Any Tickets that cannot be used must be returned to the Club's ticket office as soon as reasonably practicable.

### 7. Ground Regulations and Conduct

- 7.1 All attendees must comply with the Terms and Conditions of Entry and all reasonable instructions given by stewards or Club officials.
- 7.2 The Club reserves the right to refuse entry to, or remove from the Stadium, any individual whose behaviour is unsafe, disruptive, or in breach of the Ground Regulations.

### 8. Changes, Cancellation and Force Majeure

- 8.1 The Club reserves the right to amend, suspend or withdraw the Offer at any time.
- 8.2 The Match may be rescheduled, relocated or cancelled due to circumstances beyond the Club's reasonable control or as required by a Football Authority. No compensation will be payable in such circumstances.

### 9. Liability

- 9.1 Tickets are provided for domestic and private use only and must not be used for any commercial or business purpose.
- 9.2 Nothing in these terms and conditions excludes or limits the Club's liability for:
  - (a) fraud or fraudulent misrepresentation;
  - (b) death or personal injury caused by the Club's negligence; or
  - (c) any other liability which cannot lawfully be excluded or limited.
- 9.3 Subject to clause 9.2, the Club shall not be liable for any indirect or consequential loss, including loss of profit, business or opportunity.

- 9.4 Subject to clause 9.2, the Club's total liability arising out of or in connection with the Offer or these terms and conditions shall not exceed the face value of the relevant Match Ticket had it not been provided free of charge in conjunction with the Offer.
- 9.5 The Club shall not be in breach of these terms and conditions where failure to perform is caused by circumstances beyond its reasonable control or compliance with the requirements of a Football Authority.

### **10. General**

- 10.1 The Club's decision regarding Ticket allocation is final.
- 10.2 These terms and conditions are governed by the laws of England and Wales, and the courts of England and Wales shall have exclusive jurisdiction.
- 10.3 No failure or delay by the Club to exercise any right shall constitute a waiver of that right.
- 10.4 If any provision of these terms and conditions is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
- 10.5 The Club may update these terms and conditions from time to time by publishing revised versions on the Website.
- 10.6 These terms and conditions, together with the Terms & Conditions of Entry and Ground Regulations, constitute the entire agreement between you and the Club in relation to the Offer.
