TERMS AND CONDITIONS FOR BOILERMAN'S BONUS BALL AT WEST BROMWICH ALBION V QPR ("the Match")

Information about other people

If you provide information to us about any other people, you must give them a copy of the [Club Privacy Policy](#) so that they understand how their information will be used. You should only provide information about them if you are authorised to do so.

1. By entering into this prize draw you are confirming that you have read, accepted and agree to be bound by these Terms and Conditions.
 2. The prize draw is free to enter, and no purchase is necessary. However, each entrant will need a season ticket that allows entry to the Match and an internet connection, and no refund may be claimed for expenses incurred in participating in the Competition, including in relation to use of the internet.
 3. The prize draw is only open to West Bromwich Albion 2026/27 season ticket holders aged 18 or over residing in England, Wales or Scotland who are attending the Match and are not suffering from any medical condition that would prevent them from participating in the Competition.
 4. Employees or consultants of the Promoter, their families, agents or any third party directly associated with the administration of the prize draw are not permitted to enter the prize draw.
 5. The prize draw shall be open for all entries received between 12:00pm on September 4, 2026 ("**Opening Time**") and 5:00pm on September 9, 2026 ("**Closing Time**"). Entries received after the Closing Time will not be considered.

1. Only one entry per person is permitted. Entries submitted on behalf of another person will not be accepted, and joint submissions are not allowed. The Promoter reserves all rights to disqualify any entrant if their conduct is contrary to the spirit or intention of the prize draw.
 2. Entries submitted that are (a) automatically generated by a computer, (b) completed by third parties or in bulk, (c) illegible, have been altered, reconstructed, forged or tampered with, (d) incomplete, (e) submitted by an individual not eligible to participate in the prize draw, and/or (e) fraudulent are not valid entries and will not be submitted into or removed from the prize draw.
 3. By entering the prize draw, you confirm that you are eligible to do so and eligible to claim the Prize(s). The Promoter may require you to provide proof that you are eligible to enter the prize draw.

example, due to equipment failure, a technical fault, technical malfunction, computer hardware or software failure, satellite, network, systems or server failure of any kind. The Promoter will not accept proof of transmission as proof of receipt of entry to the prize draw. The Promoter accepts no responsibility for any entries not validly completed for any reason.

5. One winner of the prize draw will be chosen by random draw within 24 hours of the Closing Time. The Promoter will make all reasonable efforts to contact the prize draw winner by notifying the prize draw winner via email or phone (where relevant contact details are provided) within 24 hours of the Closing Time. A prize draw winner must provide their name and a postal address to participate in the Competition. Such postal address must be a residential address in England, Scotland or Wales. If the prize draw winner cannot be contacted or is not available or has not claimed the chance to participate in the Competition or has not confirmed they will attend the Match and want to participate in the Competition within 24 hours of being notified by the Promoter, then the opportunity to participate in the Competition will be forfeited and the Promoter will be entitled to select another prize draw winner in accordance with the process described above. The prize draw may not be claimed by a third party on a prize draw winner's behalf. You warrant that all information submitted by you to the Club is true, accurate and complete. To participate in the Competition, a prize draw winner must attend the Match and be available to participate in the Competition during the half time interval. No Match tickets will be provided to the prize draw winner or any other person. No guests of the prize draw winner may accompany the prize draw winner on the pitch.
6. The winner of the prize draw will receive the opportunity to participate in a competition to win a range of prizes on the Hawthorns pitch during the half time interval of the Match ("the **Competition**"). The winner of the prize draw will have three attempts to kick a ball towards a target which is laid out on the pitch. The target will display six different Prizes that are available to win, namely a pie and drink, an away mascot package, a shop voucher to the value of £50, a signed team sheet, a signed shirt, and a family tour of the stadium for two adults and two children ("the **Prize(s)**"). If the ball lands on the target in any of the three attempts, the winner of the prize draw will win the Prize on which the ball lands. The prize draw winner will have the opportunity to win one or multiple Prizes. For example, if the ball lands on the target in the first and third attempts, they will be eligible to claim the Prize on which the ball lands during attempts one and three. No practice attempts are allowed unless permitted by the Promoter on the day of the Match (although any practice attempt allowed will not count towards the three attempts and therefore no Prize(s) can be won as a result of the ball landing on the target during the practice attempt). No Prize(s) will be awarded if the prize winner fails to land the ball on the target during any of the three attempts. The Promoter will determine whether a Prize has been won, and its decision shall be final. The ball used will be the ball provided by the Promoter. The Prize(s) are subject to availability and the Promoter's terms and conditions. If any Prize(s) are won, the promoter will contact the winner of the prize draw within five working days of the Match to organise the collection or postage of the Prize(s).
7. When participating in the Competition, the prize draw winner must (i) act responsibly and sensibly at all times; (ii) not participate if they are under the influence of alcohol or drugs, (iii) not participate if they are unwell and/or are displaying symptoms of any infectious disease (including Covid-19), (iv) use any equipment provided to the prize winner safely and as described, (v) follow any safety warnings or instructions displayed or given to them in respect of the Competition, (vi) comply with Club rules at all times, and (vii) supply their own footwear that is deemed appropriate by the Promoter and wear their footwear throughout their participation in the Competition.
